The ITA is allowed as a deduction of 100 percent qualifying capital expenditures against company's statutory income. Only qualifying expenditures incurred in the first five (5) years commencing from the effective date after MSC Status is granted will qualify for 100 percent ITA. ITA may be carried forward indefinitely to be deducted against its statutory income until it is fully utilized.
